Copy of said award is already marked to the Stock Exchanges as well as NSDL/CDSL. However, as per secton 12 of the Depositories act,1996 read with REgulation58 of the SEBI(Depositories and Participents) Regulations,1996,above said equity shares(i.e.18.70%) held by the promoters have not been marked as pledged. Morever, as per our register of members dated december 31,2010 based on data received from NSDL /CDSL through our RTA, M/s Link iintime India Pvt.Ltd,the said shares have not been marked as pledged or otherwise encumbered. Further, since the arbitration matter is still going on and promoter companies have not reported pledge of these shares and also Register of Member showed aforesaid shares as unencumbered or free, accordingly we have reported these shares in promoters shareholding as unencumbered as per legal openion of an expert obtained in this regard.
