SUB : Intimation on Window Closing under Insider Trading Regulation and Compliance of Code of Conduct for prevention and Regulation of Insider Trading of Golden Tobacco Limited:

This is to inform you that the Board Meeting of the Company is scheduled to be held on Thursday, February 11, 2016 at Mumbai.

Pursuant to the requirement of the SEBI (Prohibition of Insider Trading) Regulation, 2015 the Board of Directors of the Company had approved the "Code of Conduct" (the Code) to Regulate, Monitor and report trading in securities by insider in the Company for prevention of Insider Trading within the organization.

Accordingly, the trading window shall remain closed from February 01, 2016 to February 12, 2016 (both days inclusive) *before the happening of the ' Price Sensitive Information' or events/ publication of the quarterly results for the quarter ended December, 2015.*

"Price Sensitive Information" means any information which relates directly or indirectly to the Company and which if published is likely to materially affect the price of securities of the Company;

The following, among other things, will be treated as Price Sensitive Information:-

- i. periodical audited or unaudited financial result of the Company, standalone or consolidated;
- ii. Intended declaration of dividends (both interim and final);
- iii. Issue of securities by way of public, bonus, rights etc or buy-back of securities;
- iv. Any major expansion plans or execution of new projects;
- v. Amalgamation, Mergers, Takeovers, or Restructuring;
- vi. Disposal of the whole or substantial part of the undertaking;
- vii. Any significant changes in policies, plans or operations of the Company;
