### **SUB: Intimation on Window Closing under Insider Trading Regulation and Compliance of Code of Conduct for prevention and Regulation of Insider Trading of Golden Tobacco Limited:**

This is to inform that the Board Meeting of the Company is scheduled to be held on Thursday the November 13, 2014 at Mumbai.

The Board of Directors had approved the "Code of Conduct" for Prevention of Insider Trading within the organization. In line with the approved "Code of Conduct" , read with SEBI Insider Trading Regulation, the "Trading Window" shall be closed effective from November 5, 2014 to November 14, 2014 for "10 days before the happening of the 'Price Sensitive Information' or events and shall remain close up to 24 hours after the publication thereof."

**"Price Sensitive Information"** means any information which relates directly or indirectly to the Company and which if published is likely to materially affect the price of securities of the Company;

The following, among other things, will be treated as Price Sensitive Information:-

- i. Periodical Audited or un-audited financial result of the Company, standalone or consolidated;
- ii. Intended declaration of dividends (both interim and final);
- iii. Issue of securities by way of public, bonus, rights etc or buy-back of securities;
- iv. Any major expansion plans or execution of new projects;
- v. Amalgamation, Mergers, Takeovers, or Restructuring;
- vi. Disposal of the whole or substantial part of the undertaking;
