The Company had offered e-voting facility through CDSL to all the members of the Company in compliance with the aforesaid provisions of the Companies Act, 2013 and Clause 35 B of the revised Listing Agreement to enable them to cast their vote electronically from September, 21, 2014 at 9.00.A.M. to October 20, 2014 up to 6.00 P.M.

To oversee the E-voting process and postal ballot, the Board of Directors of the Company had appointed Mr. S. Samdani ( FCS 3677) , a practicing Company Secretary in Vadodara, Gujarat as the scrutinizer.

Mr. S. Samdani had scrutinized the votes cast through e-voting and postal ballot and combined the votes cast under both method and submitted his report to the Company. The results of e-voting and postal ballot was announced by the Company Secretary on October 27, 2014 as are under :
