To oversee the E-voting process and postal ballot, the Board of Directors of the Company had appointed Mr. S. Samdani (FCS 3677), a practicing Company Secretary in Vadodara, Gujarat as the scrutinizer.

Mr. S. Samdani had scrutinized the votes cast through e-voting and postal ballot and combined the votes cast under both method and submitted his report to the Company. The results of e-voting and postal ballot was announced by the Company Secretary on October 27, 2014 as are under:
